Festival Rules

REVISED - READ CAREFULLY!

Food Vendor Rules and CRITERIA:

1) All food vendors MUST adhere to county, state regulations and comply with the sales tax laws of NC. (See Info regarding sales tax laws--this in attached info sheet New for 2016)

2) NO WEAPONS allowed

3) Soft Drinks, Tea, lemonade, water and coffee may be sold, **no alcoholic beverages allowed**

4) A \$50.00 fee will be assessed to anyone not cleaning up his or her space.

5) A Brunswick County Health Inspector will be on site to inspect each unit.

NOTE: You have to have a temporary Food Stand Permit from the Health Dept before you can sell any food. (call the health department if you have questions see attached info from the Brunswick Co Health Dept)

LOCATION: Leland Town Park off of Village Road Leland NC

TIME OF SHOW: ~

1) Saturday, December 09, 2017 ~ 10:00 a.m. - 4:00 p.m. (no vehicles allowed on street after 9:00 a.m. until the parade is over around noon))

2) You must park vehicles in the area lot beside the existing Town Hall administrative offices or at the Town's Animal Shelter area (in the wooded area). You will be given a parking placard mailed to you. You'll need to post this in your vehicle window when arriving at the festival location. You may setup the night before but will need to notify us in this application

SET-UP TIMES:

1) This is an outdoor show. Exhibitors must provide their own tables, displays, and tents for shelter from rain or sun. Electricity and water under pressure is available on a limited basis.(must call for more information)

2) All tents and displays must be free-standing, secured with weights – or with stakes in the ground.

3) Vendors may set up on Friday, December 08, 2017 after 5:00 p.m. **must notify the Food Booth Chairman**

4) All vendors must be set up on Saturday, December 09, 2017 by 9:00 a.m.

~ **Village Road will be closed by 9am on Dec 9th!**

5) Vendors may not pack up before 3:00 p.m. on Saturday (9th)

ENTRY FEES (per space): ~ ALL SPACES ARE 12' x 12' ~

1) All fees are non-refundable

2) Food Vendor \$100.00
